### **IMPORTANT PERMIT REQUIREMENTS**

- Before burning, call **541-776-7007** to verify that it is a **Burn Day**.
- No burning will be allowed **during declared fire season**, when the ventilation index is **less than 400**, when **wind speeds exceeds 20 mph**, or when the **temperature exceeds 90°F**.
- Permittee must extinguish fire if conditions change during burning.
- IT IS UNLAWFUL** to burn Construction Debris, Wet Garbage, Wire Insulation, Automobile Parts, Asphalt, Petroleum Products/Treated Material, Plastic/Rubber Products, Animal Remains or Animal/Vegetable Matter resulting from the handling, preparation, cooking or service of food; or any other material which normally emits dense smoke/noxious odors.
- Burn piles must be a manageable size to allow for extinguishment should conditions change.
- Fuel breaks around the fire area must be adequate to provide separation from combustible exposures.
- Burning must be conducted under constant supervision of a person capable of taking corrective action in the event of an uncontrolled situation.
- Permit is not valid for blight burning during declared fire season. (Ag. Blight Burn Permit req.)
- ALL FIRES MUST BE EXTINGUISHED BEFORE DARK**
- If this box is checked, an inspection by Medford Fire-Rescue is **required prior to ignition**.

**This permit is valid on a calendar year basis.**

**Special conditions must be met during State Declared Extreme Fire Conditions.**

**Liability:** *This permit does not relieve the Permittee from criminal or civil liability for damages arising from burning occurring under his/her control. Violations of the burning requirements may result in the issuance of a citation or civil penalty, and/or suppression costs.*
